How do lower fees get you more money?

If your lawyer takes less money that leaves more money for you. Lawyers typically charge anywhere from 33.0% to 40.0% of the funds recovered. For example, if a case settles for \$50,000.00 for a full tort car accident, a typical lawyer would charge from \$16,666.67 to \$20,000.00. My fees would range from \$10,000.00 to 12,500.00 This results in you getting \$6,666.67 to \$10,000.00 more to help in your time of hardship.

Why do I charge lower fees?

Additionally, through the use of computers and a loyal and professional staff overhead is kept to a minimum. I do the work so I do not have to pay paralegals or other legal type assistants.

Do lower fees means less skill?

Absolutely not. I am an honors graduate from Temple University School of Law. Further, I returned to Temple University School of Law in 2004 to obtain a master's degree in trial advocacy. I am an advocate in the National College of Advocacy. I am a member of the Million Dollar Advocates Forum, a group of lawyers who have obtained a jury verdict and/or settlements in excess of \$1,000,000.00 or more. I attend annual continuing legal education seminars specifically designed to improve my skills as a courtroom attorney.
